## Mix of opinions at Parish Review meeting in June

The report on the Parish Review meeting held on 20 June 2017 has now been received from the Active Communities Team at Suffolk Coastal District Council. The report totalled 18 pages and copies are available to download on the parish website at <http://rushmerestandrew.onesuffolk.net/parish-council/parish-review/?stage=Live>

The responses on the evening provided an interesting mix of opinions regarding life in the parish which, in the 2011 census, had a population of 6,185.

The provision of infrastructure, lack of shops, attitudes to the parish council, perceived lack of synergy between the north and south of the parish, problems with cutting of hedges and verges, problems

with potholes and road markings, bus services, doctors, shops, etc, etc.

The aim of the Review was for the SCDC Planners, Active Community Team and the Parish Council to try and gain an understanding of whether there was any requirement for the production of a Neighbourhood Plan.

In order to analyse this requirement a meeting between the Active Communities Team, Planning Policy Team and the Parish Council was held on 12 September at East Suffolk House, Melton.

The agreed opinion was that all the above items raised at the Review fell outside the scope of a Neighbourhood

Plan and were local issues which in most cases could be dealt with given sufficient funding by the next tier at County and District Council level or facilitated by the parish council.

It was further acknowledged that there was little by way of potential development area in any parts of the parish which was not already covered by existing planning policies.

The Planning Policy Officers further stated that strategic planning matters from HM Government would also override Neighbourhood Plans as would certain aspects of

the National Planning Policy Framework (NPPF).

Another interesting aspect of Neighbourhood Plans (NPs) was that the view by the Planning Officers was that NPs were better for shaping development rather than being able to prevent it completely.

The dichotomy of the situation is that residents want shops, doctors, better transport links etc, but nowadays these only come with housing development, as without customers commercial enterprise is unsustainable.

There are notable exceptions of course in the shape of 'community' shops and facilities provided by the local populace working together.

At the Parish Review meeting the 100 or so people attending were asked on three occasions during the meeting that if anyone wanted to volunteer to help, should

a Neighbourhood Plan be considered viable, they should sign the sheets being circulated. Only blank forms were returned to the top table at the end of the meeting!!

# Overgrown verges on Bixley Farm

As a keen environmentalist, I always like to have an article about nature in Rushmere St Andrew. Once again, this year we have seen a massive growth in the hedgerows and wildlife areas within Rushmere St Andrew. Looking around there is an abundance of berries which bodes well as a good winter stock for the birds and other animals.

Of course, coupled with this huge fruit crop all the grass verges and hedgerows beside footpaths have put on a significant growth spurt. As a Parish Council we continually receive calls regarding the state of the grass verges etc. We don't have a responsibility for any of these (apart from areas within our play spaces and two open grass areas which lead to play spaces).

So, 'who owns what?' is the question. Throughout Rushmere St Andrew grass verges and (mostly) grassed open spaces are maintained by Suffolk Coastal Norse on behalf of both Suffolk County Council and Suffolk Coastal District Council. Typically for example, will be a street with a grass verge beside the footpath. If the grass is directly next to the highway then it'll most likely be County Council. They are also (as Highways Authority) responsible for maintaining street and footway lighting so

the first metre from the road is where most of those supplies run.

In parts of the Bixley Farm area of the Parish, Chater Land Holdings Ltd retains a responsibility to care for some grass verges and public open spaces. There were some problems with maintenance work normally carried out by the Chater Group and the Parish Council received a number of requests from residents regarding overgrown areas. Some of these maintenance issues have now been resolved.

With the advent of 'cut-backs' open grass areas, grass verges outside house and public open spaces which should be continually maintained by those local authorities are receiving far less attention than they ever did. There is a published schedule for cutting but that got well behind this year. As a consequence, several locations in the Parish have begun to look really 'scruffy'.

So, what is the remedy? In many cases it's quite possible for the adjacent householder to take the mower out a few yards and trim the verge. Lots of you already do so.

We would never advocate that you trim anything beside the highway that would place you in danger.

Another continued problem is where a hedgerow, clearly part of someone's garden

is allowed to grow out over the public footpath. So, please take a look. Is your hedgerow causing a problem? If so, now is the time to do the work as the bird nesting season draws to a close.

## Bixley Farm/Boadlands Way

A significant part of Bixley Farm (off Broadlands Way) was developed by other builders rather than the Chater Group. There have been several issues regarding areas of vegetation 'outside' people's gardens. A couple of years ago one such case was followed through back to the company which took over from the builders many years ago. They (the company) set about tracing historical documentation including Land Registry searches.

The results clearly show that in most cases where there is a brick wall or a wall with some wooden fence parts as the 'boundary' with vegetation growing beyond that up to the public footpath, then the curtilage of the property includes that area of vegetation. As such it means that it is the householders who should maintain those areas.

However, we've recently seen more than one attempt at building a fence or wall beyond the original garden 'boundary' to include such areas of vegetation. The next step witnessed is that the original boundary wall is then demolished.


Quite naturally such moves have a significant impact on the street scene and, not surprising, generate complaints to the local authority. This could then lead to enforcement action via SCDC Planning Dept.

So, if you have any plans in mind along these lines you are strongly advised to seek advice from SCDC Planning Dept. Far better to get official permission rather than be notified of pending enforcement action.

I think the summary of all this is 'civic pride'. If you don't like the look of the long grass verge outside your house why not do something about it? There is so much we could do for ourselves on this subject.

One thing for sure is that the phrase 'why don't they do something about it' may trip off the tongue very easily but I'm afraid the 'they' in that phrase may simply not be available!!



# Continuing the research into the people from our parish who died fighting in WW1 – part two

1917 saw the highest number of deaths of Rushmere men, and significantly three were recorded at Arras, one at Tyne Cot and outside France and Belgium in Palestine and Malta.

I have not been able to obtain photographs for these men, but if anyone has copies or further information on any of the men from Rushmere killed during World War One, it would be much appreciated to add to the records I already have.

## Frederick Arthur FISK

Born: 1883, Dennington

Died: Reported Missing October 1917.  
Died 4 October 1917. Remembered with Honour at Tyne Cot Memorial.

Rank: Private 235170.

Regiment: 8th Battalion Lincolnshire Regiment.

Medals: Victory and British.

Parents: George and Florence Fisk of 89 Orwell Road, Ipswich. Husband of Annie Eliza Fisk of The Drift, Rushmere. Annie and Frederick married in 1907 and were living at Stoke by Nayland in 1911, where Frederick was working as a shepherd. They had two children at that time Stanley, 3 and Ernest, 6 months.

## George Frederick MINTER

Born: 1895, Trimley St. Martin, Suffolk.

Died: 30 December 1917. Remembered with honour at Chatby Memorial, Egypt.

Drowned at sea on board HMS Aragon, a troop ship ordered out of port at Alexandria Roads (Egypt), destroyed by German submarine torpedoed – 610 killed. On her arrival at Alexandria on 30 December 1917,

the ship was permitted to enter the harbour, but later was ordered out again. She anchored outside without any protection from submarine attack, for which she was an easy target. This piece of indiscretion on the part of the authorities did not remain long unpunished, for the Aragon was torpedoed and sunk by German submarine UC-34.

Rank: Private 8511.

Regiment: 3rd Battalion Norfolk Regiment.

Enlistment Location: Ipswich.

Date of Entry Therein: 16 August 1914.

Medals Awarded: Victory, British War and 1914 Star + Clasp.

Brother to ARTHUR HENRY MINTER.

George is also remembered at Ipswich War Memorial.

## Bertie William SPURGEON

Born: 1888, St. Clement's, Ipswich.

Died: 11th October 1917; age 29. Died – Cottonera Military Hospital. Buried in Pieta Military Cemetery C.XV.6. Malta.

Rank: Private 50017.

Regiment: Machine Gun Corps (Infantry), 84th Coy. Formerly 17469, Suffolk Regiment.

The Machine Gun Corps was formed in October 1915 as the machine gun proved to be held affective as infantry support in trench warfare. Cavalry and Motor Branches, followed in 1916 by the Heavy Branch. A depot and training centre was established at Belton Park in Grantham Lincolnshire also a training base depot at Camiers in France. The men were trained to a higher technical standard, capable of

stripping down and mending the guns in the field.

The Machine Gun Corps had 62,049 casualties, including 12,498 killed out of 170,500 officers and men, earning it the nickname 'the Suicide Club'. This was mainly as machine guns were static or fix positions, becoming prime targets for the enemy.

Enlistment Location: Ipswich.

Date of Entry Therein: 12 May 1915 – France.

Medals Awarded: Victory, British War and 1914-1915 Star.

Parents: Arthur and Agnes Spurgeon of 38 Holland Road, Ipswich.

In 1912 in Ipswich, Bertie married Rose Page, born 1886 at Bentley, Suffolk. They had 2 children:

Bertram Thomas Spurgeon, born May 1913 in Ipswich; and Edith May Spurgeon, born January 1915 in Ipswich.

Bertie is also remembered at Ipswich War Memorial.

## Reginald Victor WHENT

Born: 1898, Long Melford, Suffolk.

Died: 24th September 1917. Died of wounds. Buried IIA.5. Locne Hospice Cemetery, Heuvelland, West-Vlaanderen, Belgium.

Enlistment Place: Ipswich.

Rank: Private 31488

Regiment: Suffolk Regiment, 1st/4th Battalion.

Medals: Victory and British. Reginald's medals were sent to his father, Mr H. W.

Regiment: King's Own Scottish Borders, 2nd Battalion.

Formerly 201396, Royal Scots Fusiliers.

Medals Awarded: Victory and British War.

Frank's mother, Charlotte Maria Wilding, died 1905, Great Blakenham, Suffolk.

Frank is also remembered on the Ipswich War Memorial.

## Community Speed Watch

As we move into the Autumn it gives us the opportunity to reflect on reports of road traffic collisions which continue to occur across our region, and hopefully encourage drivers to plan ahead for winter. Analysis of crash scenes repeatedly shows that inappropriate speed is a significant factor when the outcome is serious injury or worse.

Indeed 'SPEEDING' is nationally recognised as one of the four main contributing factors in all collisions where there are fatalities and/or serious injury. The other three are 'DRIVING UNDER THE INFLUENCE OF DRINK OR DRUGS', 'USING A HAND-HELD DEVICE WHILST DRIVING' and 'FAILURE TO WEAR SEAT BELTS'.

As ever when you try to discuss some of these issues there are the same 'disbelievers' who will try to find every alternative to justify why they should be excluded from facts! These are facts established by the Police who have the dreadful task of sorting out the aftermath of these terrible incidents.

For our part, the Community Speed Watch (CSW) team is a group of volunteers who are trained to use a sophisticated radar gun. The Speedar device is recalibrated every time it's used and is returned annually for an overhaul and manufacturer's recalibration. When we commence a roadside check the radar gun is set to check any speed although, following strict Police guidelines, we only record vehicles travelling at 35mph or more. All our checks are conducted in 30mph zones and the locations (of which there are 13 in Rushmere St Andrew) are all ratified by the Police High Speed Road Team.

Once we identify a vehicle travelling at excess speed the details are forwarded to the Police who then send an 'advisory warning' letter to the registered keeper of the vehicle. Repeat 'offenders' are likely to receive a visit from the Police.

We've now conducted more than a dozen speed watch surveys and in doing so have identified around 100 vehicles travelling at excess speed. We have noticed that in Rushmere Village itself, along The Street, the possible presence of CSW has had an effect in reducing the overall speeding along that stretch of road. Early days yet but we will continue to operate there.

One disappointing location is that of Playford Road. This is well within the 30mph section (which commences outside the village close to the now redundant Falcon Pub) for traffic heading into our area. The entire stretch of Playford Road from Woodbridge Road East past the IIFC Training Ground and beyond the Bent Lane junction is all 30mph.

I have to say that some speeds recorded were 'frightening'. This includes several vehicles travelling well in excess of 50mph including a young motorcyclist 'caught' doing 57mph. This was mid-morning when local residents were coming and going to and from their houses; the postman and other people were making deliveries and there were several cyclists and pedestrians. Indeed the 57mph motorcyclist was required to brake heavily to negotiate another vehicle. This was on a dry day in relatively bright conditions. The consequences could have been so much different on a wet road.

As a result of our continued surveys at that location, Police action has been stepped up. We are also hopeful that some kind of (physical) speed reduction initiative may be carried out – NOT speed bumps. Such plans are at an early stage of development.

## WW1 Beacon of Light event 2018

This is to commemorate exactly 100 years to the day that the First World War ended.

Our proposed event means that we have already 'signed up' in respect of being included in this nationwide initiative. In doing so we have joined the ranks of several Parish and Town Councils across Suffolk along with hundreds across the UK.

Our proposed event is being staged at Ipswich School Sports Centre in The Street and will be held in conjunction with Ipswich School (the tenants of the Sports Centre). The school celebrates the significance of Armistice Day each year and naturally the 100th anniversary will be particularly poignant.

So as well as drawing your attention to this proposed event I'm looking for your help and support. In particular you may have names and/or photos of those you would like to be remembered on that day if they had their origins and roots in the Parish of Rushmere St Andrew.

You may also have historical photos and memorabilia relevant to the First World War. It is our intention to have a display of photos/maps and artefacts. If you are able to supply anything appropriate it will be most welcome.

I'm also looking at the possibility of locating someone living in Rushmere who was born on 11 November 1918 in that it may be possible for such a centenarian to actually light the beacon for us.

On the day itself, as well as the display mentioned, there will be refreshments and one of our local district councillors, Mark Newton, is particularly keen to make this occasion an opportunity for a village party.

Plans are still unfolding and at this stage we are looking at the idea of an 'all-ticket' affair (no charge will be made) in order to gauge numbers likely to attend. Further details in respect of tickets will be in the Spring Newsletter 2018. We have a small working group planning this event and you may wish to consider joining the group.





Youths with cars are meeting up here just to socialise, and in doing so they have been blocking parking spaces needed by other visitors, disturbing residents with shouting and excess vehicle noise sometimes into the early hours of the morning. Some have been dealt with for driving in an antisocial manner and others have been reported for other traffic offences.

#### The Anti-Social Behaviour, Crime and Policing Act 2014

This act was introduced specifically to deal with ongoing antisocial behaviour which is having a detrimental impact on the community. This is a very powerful act, and it encompasses exactly the type of behaviour being shown here.

Under this act, these youths are being issued with Community Protection Notice (CPN) Warnings which requires them to address their behaviour. The CPN Warnings actually require them to stop parking in these cars parks, to not cause a disturbance in Broadlands Way, St. Andrews Walk and Brendon Drive, and to start using the litter bins instead of just throwing things on the ground. If they ignore the warning and carry on behaving in the way they have, then they will be issued with a full Community Protection Notice (CPN).

If they ignore the full CPN, then they face going to court under the threat of a fine of up to £2,500. A number of CPN warnings have been issued already.

I have been working on these issues in collaboration with the site management company, Rushmere St. Andrew Parish Council and Suffolk Coastal District Council. As well as issuing CPNs, there will shortly be a barrier installed across the nursery car park entrance to prevent vehicles entering when the nursery is shut. Anyone identified dropping litter is to face a fine by way of a Fixed Penalty Notice.

A big part of my role is to offer advice and guidance aimed at reducing antisocial behaviour in our community. Whilst this is usually taken on board, occasionally it gets ignored and this can lead to this type of enforcement.
