In the absence of Mr Richings, the PC Vice-Chairman, Mr Wright chaired the meeting.

#### 1. APOLOGIES. APPROVAL OF ABSENCE. PROTOCOL & CONDUCT REMINDERS

The Chairman read out a statement on the Code of Conduct, protocol for debate and statutory rights to film, record, photograph or otherwise report on the proceedings of the meeting.

Apologies were noted as detailed above. Mr Nunn proposed acceptance of reasons for councillor absence, seconded by Mr Whiting, with all in favour.

Mr Francis – 840A Foxhall Road - Cars were crossing the made up kerb and verge. Agreed that this required reporting to SCC Highways although there would unlikely be any action as it would be very low priority.

Mr Wright. – Recent CSW session in Playford Road (around No.18) revealed lots of vehicles speeding – almost too many at once to be able record in each interval.

Clerk responded with:- As the officer is minded to approve the above application and RSA PC also recommended approval we do not intend to call the application in for referral to the SCDC Planning Committee.

District Cllr Newton in responding as Ward Cllr had queried the referral as there were no objections lodged on the SCDC website.

The Planning Officer had sent Mr Newton a copy of the objection but Mr Newton had stated back that there was still no copy on the website. It transpired that SCDC Officers use a different DMS system (Database Management System) to the public facing system.

The dialogue is still continuing between Mr Newton and SCDC Officers as clearly there would appear to be a procedural malfunction in updating the SCDC Planning database.

The above events were noted by Councillors and thanks recorded to Mr Newton for pursuing this important matter.

Mr Newton as District Ward Councillor had raised an issue with SCDC Head of Planning concerning the above application for development at 67 Holly Road where this PC had not been consulted – accepting the site was in Kesgrave the rear boundary abutted the parish boundary and 9 RSA residents were consulted whilst only 1 Kesgrave resident was consulted.

Mr Newton will be seeing Mr Phil Rowson at SCDC to discuss their policy on statutory and neighbour notifications.

#### b. Correspondence regarding DC/17/2168 4 Playford Lane

A guery had been raised in our initial response to the planning application as to when the PLB had been moved to accommodate this application. This raised a series of emails from the PC, Mr Newton and Mr Whiting. The implication was that the applicant had asked for the PLB to be moved and it had taken place during the consultation and review process of the Issues and Options document.

Members of this Committee expressed concerns about lack of transparency within the planning processes and it was agreed that a letter should be sent to Mr Ridley expressing deep concern about how this change in the PLB was handled at the Workshop. The letter to be written after further discussion with Mr Newton as he was on the Issues and Options Working Group along with the Clerk and neither recall this change being flagged at those sessions.

A temporary Traffic Order had been issued for the Bell Lane/A1214 Junction from 24<sup>th</sup> July to 11<sup>th</sup> August restricting right turns whilst improvements are made to the traffic light system at the junction.
