## 1. APOLOGIES, APPROVAL OF ABSENCE, PROTOCOL & CONDUCT REMINDERS

The Chairman read out the statement on the Code of Conduct, protocol for debate and statutory rights to film, record, photograph or otherwise report on the proceedings of the meeting.

No apologies received. All Councillors present (Ms Evans joined late).

#### 2. TO SIGN AS A CORRECT RECORD THE MINUTES OF THE MEETING HELD ON 13<sup>rd</sup> February 2020 The Chairman reminded Councillors to note the list of cheques issued.

Miss Cracknell proposed acceptance of the minutes with the following amendment:

Seconded by Mr Francis with ALL in favour. The minutes were duly signed by the Chairman.

Mr Newton declared a local non-pecuniary interest as a member of East Suffolk Council and also stated that he may be asked to reconsider any matter from this meeting at District Council and at any relevant Committee/Sub Committee and in so doing, shall take into account all relevant evidence and representations made at the District level before coming to a decision.

Mr Whiting declared a non-pecuniary interest as a member of Suffolk County Council he may be asked to reconsider any matter from this meeting at County Council and at any relevant Committee/Sub Committee and in so doing, shall take into account all relevant evidence and representations made at the County level before coming to a decision.

No other declarations were made.

#### b. County Councillor Report

A written report from Mr Whiting was distributed with the agenda for the meeting. Matters Arising – Mr Whiting updated Councillors on the Bixley Lane claim to be added to the Definitive Map as a Public Right of Way and plans regarding the improvements planned at Foxhall Road dump for the following financial year.

Mrs Richardson-Todd thanked Mr Whiting and Mr Hedgley for their reports.

#### d. Public Forum – Members of Public/Parish Councillors May Speak on Any Matter

Mr Francis informed Councillors that he was contacted by a group that wanted to plant a tree in Rushmere St Andrew parish. Mr Francis spoke to Mr Wright, the Tree Warden about this. Several councillors suggested locations where trees can be planted in the Parish. This item will be discussed at the next Parish Services and Amenities Committee Meeting in January 2021.

Mrs Richardson-Todd informed Councillors that she contacted the Clerk about broken posts at the access to the Little Commons. Clerk to report. She also enquired about 30mph signs at Playford Road. A discussion followed about this and it was agreed that Mr Whiting will follow this up with Suffolk County Council.

Mr Whiting reported vandalism along Playford Road.

## 5. POLICE MATTERS AND REPORT FROM SAFER NEIGHBOURHOOD TEAM (SNT)

## 6. FINANCE MATTERS

#### a. To Note Expenditure Authorised under Delegated Powers

The Clerk informed Councillors that expenditure was authorised for SCL Landscape Management Ltd to remove gravel from under the picnic bench and from Play Equipment at Broke Hall Playing Field for £40 plus VAT on safety grounds. Councillors noted this.

## b. To Consider the Bank Reconciliation and Budget Monitoring for the Period Ending 30.11.20

The Clerk distributed a bank reconciliation and budget monitoring sheet for November 2020. She explained the various figures.

Mr Richings proposed that the bank reconciliation and budget monitoring sheet for November 2020 be approved; seconded by Mr Wright and resolved with ALL in favour.

#### c. To Note Response from PWLB Regarding Loan Repayment

The Clerk reported that if the Parish Council were to continue paying the remaining seven half yearly repayments the total amount to repay would be £74,657.76. If the Parish Council made a full early repayment of the outstanding PWLB loan it is estimated that the total settlement will be £74,858.54. It would therefore cost the Parish Council £200.67 more to make an early repayment of the current PWLB loan. When a loan is settled early, a calculation is made to compare current interest rates at which the PWLB might re-lend the amount repaid over the remainder of the original period of the loan, and the rate of interest that it would have received had the original loan continued to maturity. Where the PWLB's current interest rate is higher, a discount is calculated and where the rate is lower a premium is calculated. In this case, a Premium of £6,817.86 is payable.

Councillors noted this.

#### d. To Consider the GP&F Committee Budget 2021/22; and

## e. To Recommend to the PC a Council Budget & Precept for 2021/22

The Clerk made a draft copy of a proposed GP&F budget available that laid out a suggested expenditure (after allowance for income) of £102,332 for 2021/22, an increase of £9,450 on the current year. The Clerk then made a draft copy of the Parish Council budget available to Councillors.

In normal years there is very rarely any difference between the tax base in October/ November that we receive from ESC and the final approved tax base figures that we receive from East Suffolk Council. However, this year the impact of the COVID-19 pandemic has meant that the calculation has been subject to a very high degree of uncertainty as advised by East Suffolk Council. A discussion followed about the GP&F budget and the Parish Council budget.

Mr Richings proposed that the given this uncertainty regarding the final tax base figures the GP&F Committee recommended a 0% precept increase to the Parish Council meeting in January 2021, seconded by Mr Wright. Resolved with MAJORITY in favour.

## e. Other Matters

The Clerk reported that the Parish Council received the External Audit report. No issues were raised. The report will be considered at the Parish Council meeting in January 2021.

## 7. CEMETERY MATTERS

## a. To Approve the Cemetery Fees for 2021/22 Recommended by the Cemetery Panel

The Clerk reported that the Cemetery Management Advisory Panel recommended that there is no increase to Cemetery Fees and that the fees remain the same for 2021 with a comprehensive review of fee for 2022.

Miss Cracknell proposed no increase to Cemetery fees for 2021 and a comprehensive review of fees for 2022, seconded by Mr Griggs and agreed by ALL.

## 9. GENERAL PARISH MATTERS AND CORRESPONDENCE

## a. To Consider and Approve Rubbish Bin (with flaps) at Broke Hall Playing Field

The Clerk reported that PA&S approved that an extra rubbish bin be installed at Broke Hall Playing Field but recommended that adding flaps to the bin be considered. A rubbish bin would cost  $\pounds$ 225 + VAT and adding flaps to the bin would cost  $\pounds$ 300 + VAT.

Mrs Brown proposed that a rubbish bin with flaps at a cost of  $\pm 300 + VAT$  be installed at Broke Hall Playing Field. Seconded by Mr Wright with MAJORITY in favour.

## b. Parish Walks

Mrs Richardson-Todd informed Councillors that she thinks it would be beneficial to organise parish walks and look at publishing information on walks around the parish. This will be considered by the Parish Amenities and Services Committee.

## c. To Note Matters Since Publication of Agenda

The Clerk informed Councillors that the Parish Council has been notified of the temporary closure on a public right of way. This is Rushmere St Andrew Footpath 23 from Woodbridge Road, Rushmere St Andrew for 40 metres northbound. The reason for the closure is in the interest of public safety to enable UK Power Networks to carry out electrical works. The footpath will be closed from 15/02/2021 to 18/02/2021. The alternative route identified is Woodbridge Road to Bent Lane, Rushmere St Andrew and vice versa.

The Clerk reported that she received correspondence from Mr David Last, Definitive Map Officer at Suffolk County Council. He has prepared a draft report that will be presented to the Rights of Way Committee in February recommending that a modification order be made under section 53(3)(b) of the Wildlife and Countryside Act 1981, to add a public footpath (Bixley Lane) to the definitive map.

The Clerk reported that East Suffolk District Council has commissioned a leisure strategy comprising open space, outdoor sports facilities and indoor built facilities assessments in East Suffolk. This will in turn then result in the production of an Open Space Strategy, Playing Pitch Strategy and Indoor Built Facilities Strategy. The Study will examine the quality and distribution and use of open space across East Suffolk District Council. The Parish Council has been asked to participate in the study.
