

# Rushmere St. Andrew Lawn Cemetery

## SCHEDULE OF FEES

### Effective from 1st January 2022

This table of fees should be used in association with the Regulations (Third Edition: July 2018) made by Rushmere St. Andrew Parish Council acting as The Burial Authority.

The indicated non-resident fee is payable when a non-resident of the civil Parish of Rushmere St. Andrew is interred. A resident is a person who, at the time of death, is or was an inhabitant of Rushmere St. Andrew. For a stillborn child the fees will be charged according to the residence of the parent(s). Resident fees will apply for the burial of a non-resident in a grave for which the rights of burial were previously secured and used for a resident of Rushmere St. Andrew.

#### **1 BURIAL FEES**

##### **1.1 Public Graves Interment (for which no exclusive rights of burial will be granted, see also Regulation 13).**

- (i) Child up to 16 years of age
- (ii) Adult over 16 years of age

##### **1.2 Purchase of exclusive rights to a new grave burial plot.**

For the exclusive right of burial (adult or child) in a lawn garden grave space for a period of 100 years (see Regulation 2).

##### **1.3 Interment fees per interment in a new or reopened grave.**

- (i) Child up to 16 years of age
- (ii) Adult over 16 years of age

**Note:** Where the interment of two or more bodies takes place at the same time in the same grave then an appropriate interment fee will be charged for the first (adult) body and 50% of that fee for each other body.

##### **1.4 Interment of cremated remains in a grave space.**

For each interment of the cremated remains (adult) in an existing grave space for which an exclusive right of burial had been granted.

#### **2 URN BURIAL OF CREMATED REMAINS**

Urn burial plots are assigned by the Burial Authority for this purpose.

##### **2.1 Purchase exclusive rights to a new urn burial plot.**

For the exclusive right of burial of cremated remains (adult) in a lawn garden urn burial plot for a period of 100 years (see Regulation 2).

##### **2.2 Interment of cremated remains in an urn burial plot.**

For each interment of the cremated remains (adult) in a new urn burial plot for which an exclusive right of burial had been granted.

### **3 LOOSE BURIAL OF CREMATED REMAINS**

Placement of loose ashes in a pre-designated area within the Lawn Cemetery for which no exclusive rights of burial are required and no memorial headstone is permitted. *NOTE: Formal registration in the Register of Burials is, however, required and ashes cannot be placed or scattered on the surface of the ground (under the turf is the normal method).*

### **4 MEMORIAL & MISCELLANEOUS CHARGES**

#### **4.1 For the right to erect or place;**

- (i) A headstone or cross on a grave space with inscription. (see Regulation 15).
- (ii) A memorial on an urn burial plot with inscription (see Regulation 16).
